NOTES:

- Emission of a duplicate of the marketing authorization is made only upon request, based on the documents attesting the loss of the document by publishing in the Official Gazette of Romania, Part III,
- In case of grouped variations, the tariff is calculated for each marketing authorization, by summing the appropriate tariff of the variation that defines the group and 75 % of the tariff of the variation included in the group, other than the variation that defines the group,
- For type I, II or group of variations, requested by “Equitable distribution of tasks” (worksharing), the same tariff established for variations of type I, II or group of variation depending on the type of procedure applies,
- The annual tariff for maintaining on the market the marketing authorization for veterinary medicinal products will be paid within first 6 months of the current year for all marketing authorizations valid at 31 December of the previous year.
